What, why, and how.

Chapter 7.70 – Water Wells

- 1. It is the purpose of this chapter to provide for the location, construction, repair, and reconstruction of all wells... to the end that the groundwater of this County will not be polluted or contaminated and that water obtained from such wells will be suitable for the purpose for which used and will not jeopardize the health, safety or welfare of the people of this County.
- 2. It is also the purpose of this chapter to provide for the destruction of any abandoned wells...which may serve as a conduit for movement of contaminants, or which are found to be a public nuisance, to the end that such a well will not cause pollution or contamination of groundwater ...
- 3. It is also the purpose of this chapter to implement policies of the County General Plan and the Local Coastal Program Land Use Plan.

Chapter 7.73 – Individual Water Systems

- 1. It is the purpose of this chapter to establish standards for safe and adequate water supplies for individual water systems and to ensure that such systems do not induce contamination of aquifers and therefore jeopardize the health, safety and welfare of the people of Santa Cruz County.
- 2. It is also the purpose of this chapter to implement policies of the County General Plan and the Local Coastal Program Land Use Plan.

Not included:

- 1. 7.71 Water Systems. This chapter is not part of the LCP, is focused more on the regulatory aspect of water systems and is largely based on state law, and was updated in 2015.
- 2. Wells drilled within cities Each city has their own approach to well permitting. Some rely on the County for some or all permits, and others do it themselves. Once the update is complete, we will update our agreements with the cities.

PROCESS

- 1. Data Collection and Process Review
- 2. Prepare draft Well Ordinance Update Recommendations Table
- 3. Engage Water Advisory Commission for review and approval
- 4. Engage Technical Advisory Committee for challenging issues
- 5. Engage key partners for review and revisions
- 6. Provide conceptual/draft updated Well Ordinance to BOS for review and approval (Fall 2024)
- 7. Complete CEQA/environmental review
- 8. Public hearing at the Planning Commission for their recommendation on the draft Ordinance (Local Coastal Program [LCP] Amendment) Coordinate with Planning
- 9. The BOS would consider the recommendation and adopt the ordinance.
- 10. The adopted ordinance would be submitted to the Coastal Commission for certification.
- 11. Distribute to GSAs, cities, local jurisdictions and develop formal agreements if needed
