Procedure Requirements

Section 119308

Prior to a procedure:

Wash and dry hands. Put on clean apron, bib, or lap pad over clean, dry clothing. Put on the PPE (personal protective equipment) that is appropriate to the task. Don disposable exam gloves just prior to the procedure. If gloves come into contact with an object or surface other than the client's prepared skin or material to be used for the procedure, or if a glove is torn or punctured, both gloves shall be removed, hand washing performed, and new clean gloves shall be donned. If gloves are removed for any reason during a procedure, hand washing shall be performed prior to donning new gloves.

If skin is to be shaved, wash it with soap and water first. Shave using a single use disposable razor that is discarded into a sharps container. Immediately prior to performing a procedure, prepare clients skin with an antiseptic solution.

At completion of procedure you must: answer questions regarding the site, provide post procedure instructions, place all used sharps in approved container, wash and disinfect reusable instruments, decontaminate workstation.

Only:

- single use stencils and marking agents, including pens (unless they can be disinfected), and commercially manufactured inks, dyes and pigments can be used. 119311(b)
- jewelry that meets materials standards set forth in Section 11930 may be used in newly pierced skin:
 - o ASTM F138, ISO 5832-1, and AISI 316L or AISI 316LVM implant grade stainless steel, solid 14-karat through 18-karat yellow or white gold, niobium, ASTM F 136 6A4V titanium, platinum, or other materials found to be equally biocompatible.

No food, drink, tobacco product or personal effects are permitted in the procedure area.

- (a) A product applied to the skin prior to tattooing or application of permanent cosmetics, including, but not limited to, stencils and marking and transfer agents, including pens, shall be single use and discarded into a waste container at the end of the procedure unless the product can be disinfected for reuse.
- (c) Inks, pigments, soaps, and other products in multiple-use containers shall be dispensed in a manner to prevent contamination of the storage container and its remaining contents through the use of a single-use receptacle.
- (d) Inks and pigments shall be placed into a clean, single-use receptacle. The inks and pigments remaining in the receptacle shall be discarded immediately upon completion of the procedure.
- (e) Needles, needles, needle bars, grommets, and razors shall be discarded into a sharps waste container immediately upon completion of the procedure.
- (h) Any part of a tattooing machine that may be touched by the practitioner during the procedure shall be covered with a disposable plastic sheath that is discarded upon completion of the procedure, and the machine shall be decontaminated upon completion of the procedure.

Tear down:

- (a) The practitioner shall maintain a clean and sanitary environment.
- (b) All solid surfaces and objects in the procedure area and the decontamination and sterilization area that have come into contact with the client or the materials used in performing the body art, including, but not limited to, chairs, armrests, table, countertops, and trays, shall be immediately decontaminated after each use and then disinfected by application of a disinfectant, used according to manufacturer's directions.
